G. OLD BUSINESS – Budget FY17

1. Facilities Management – Page 18 Robert Jarman, Facilities Director

Line 938 – Mr. Jarman stated they have to change the R22 air conditioners to 410A. He stated it will be less cost to the County in the long run to replace the old units than buy compressors and R22 Freon to fix them. He stated he is budgeting to replace 8 or 10 per year.

Supervisor Caldwell asked if there is additional funding for the courthouse lawn. Mr. Jarman said he will have enough in his budget to cover that.

Line 903 – Parking lots & sidewalks – Mr. Jarman stated they are planning some significant repairs around the County.

Line 438 – Mrs. Freeze stated this is an increase to adjust employee salaries. Mr. Jarman stated this was a clerical error that resulted in too money being taken out for custodial salaries, and he has had this position that was not completely funded.

Line 468 – Mrs. Freeze stated this is the true up related to insurance.

Supervisor Caldwell asked what Mr. Jarman planned for the position he is requesting to be funded. Mr. Jarman stated he plans to hire a plumber. Supervisor Gardner asked would he need a new vehicle for that person. Mr. Jarman stated he will probably keep one of the older vehicles he had planned to surplus and let the employee designated to the jail drive it as he will not drive very much.

Line 510 – Mr. Jarman stated the utilities increase is for the additions of the new half of the jail, Sheriff's admin building, juvenile detention center will be busier as more of the building is used, and the new land records office.

Line 540 – Mr. Jarman stated his department is taking on a lot more of the service calls, but the additions listed above will make this line increase.

Line 580 – Mr. Jarman stated he has added the Animal Shelter, and the new additions.

Line 641 - Mr. Jarman state this is an anticipated increase in in-house work. He stated he will bring special projects to the Board for approval, but he will do painting and repairs as usual.

Mr. Jarman presented a list of special projects as listed on Exhibit G.1.

2. Environmental Services – Pages 56, 92, & 93 - Ray Laughter, Manager

Page 56 – Mrs. Lynchard stated the reduction of \$6,291 is because of Mrs. Freeze and Mrs. Hanks truing up the numbers.

Page 92 – Line 523 – Contractual Printing – Mrs. Lynchard stated the extra money requested in this line needs to be removed as the Solid Waste Committee has determined not to do the recycling survey this year. It will remain flat.

Line 554 – Consultant Fees – Mr. Laughter said this is for Mr. Jim McNaughton's continuing services and work that needs to be done next year. The request is for \$25,000.00 in FY17.

Line 582 – Disposal Fees – Mr. Laughter said they are asking for an additional \$25,000.00 and if the numbers stay the same, this should cover next year.

Line 583 – Recycle Disposal – Mr. Laughter stated this line needs to increase by \$10,000.00 because of

market prices, mostly Ewaste costs.

Line 596 – Waste Tire Disposal – Mr. Laugher stated there is a growing awareness and promotion of the Program. He also stated the cost is reimbursed by an MDEQ grant. Increase of \$1,200.00. Line 270 – Mrs. Lynchard stated this is the grant revenue line and it has an increase in anticipated revenue.

Supervisor Medlin stated he is on the solid waste committee; and he feels all the funds requested will be needed, as recycling no longer generates income.

Supervisor Lee Caldwell made the motion and Supervisor Jessie Medlin seconded the motion to approve the budget and special projects for Environmental Services with the extra funds requested for contractual printing removed.

3. Recreation District Fund – Page 90

Line 101 – Mr. Laughter stated this money was given by the developer for a park at Hawks Crossing. Mrs. Freeze stated the money was in the General Fund in a balance sheet account. Mrs. Lynchard stated this kind of money can be lost if not put in the correct Fund and this was very hard to find.

Line 907 – Mrs. Lynchard stated Mr. Jarrett requested to move this money to Line 909 to make it easier to utilize. See Exhibit G.3. for a list of proposed projects to be completed with no increase to taxpayers. Greenways gets many grants and volunteer work according to Mr. Jarrett.

Supervisor Medlin asked what Line 387 Transfers in from Govt. Funds was. Mrs. Freeze stated that is the allocation from the County.

Supervisor Caldwell stated she would like to see all the County parks under one umbrella with a Parks Director. She stated she would rather the money not go to Economic Development Council, but establish a Parks and Recreation Department that would start under the umbrella of Environmental Services. She stated the County needs someone to manage all the parks' day-to-day operations and be the person that volunteers report to.

Supervisor Lee Caldwell made the motion and Supervisor Mark Gardner seconded the motion to table the Recreation District Fund budget request and authorize Board Attorney Tony Nowak to investigate the feasibility of establishing a County Parks & Recreation Department.

4. IT & GIS – Pages 19, 123, 11, & 95 – IT Director John Mitchell

Page 19 – Line 440 – Request to add \$11,000.00. Mr. Mitchell stated he had \$4,000.00 that was used one summer for an intern. He said he is looking to hire someone to work the middle part of the day, help with volume of calls on help desk and handle minor things. He said this person will also be able to help on the GIS side when the public comes in and wants a map. Mr. Mitchell said he wants citizens to get high priority treatment. He said a part-time person would be beneficial to both departments.

Line 574 – This is for domain registries.

Line 924 – Mr. Mitchell said this is for increase in support and software for all departments.

The Board discussed the \$30,000.00 the Sheriff was requesting for computer equipment and the apx. \$27,000.00 that was being used in IT for licenses and storage maintenance. Mr. Mitchell stated the licensing gives his department the ability to restore data if a computer crashes, even in the deputy's cars. He stated it is backed up every night, and has a very strong firewall to overcome virus infections. Mr. Mitchell stated the support is well worth the added expense. Sheriff Rasco stated Chief Deputy Macon Moore works closely with Mr. Mitchell to be sure their purchase of new equipment fit within the system being used.

Mr. Mitchell also pointed out he pays for the Sheriff's cell phones with E-citation Funds. He said if the State pulls back that money, he will have to find it elsewhere within the budget. He stated that is what the \$35,593 increase reflects.

Supervisor Mark Gardner made the motion and Supervisor Lee Caldwell seconded the motion to approve the IT budget as presented on page 19 with the exception of authorizing raises at this time.

Page 123 – Line 559 in Fund 380 Dept. 152 – Mrs. Lynchard stated if the Board is planning to move forward with the Countywide software purchase, it is recommended to put in \$1,000,000.00 per year for the next five years. Mrs. Lynchard stated it would not be practical to upgrade all departments at the same time.

Supervisor Caldwell asked if this recommendation was so the overall plan could be implemented quicker. Mr. Mitchell said he recommended the plan get underway as soon as a vendor can be selected.

Supervisor Gardner asked what the top priority would be. Mr. Mitchell stated he would recommend Justice Court first, then General Ledger Core Financials; as Chancery is already in progress. He felt these departments would be the quickest benefit and the ones most prepared to move forward.

Mrs. Lynchard stated they recommend using some of the .44 mills to fund part of this transfer. She stated there is additional millage because the debt service went down. She recommended this because this is a recurring expense for 5 years, and this would put the Board in a great position to do other

projects out of ending cash. Mrs. Freeze stated the .44 mills would be apx. \$628,000.00 and they are recommending moving \$385,200.00 into this fund.

Supervisor Caldwell asked if the first \$1,000,000.00 will get the base part of the new software. Mr. Mitchell said it should be no more than \$1,500,000.00. Supervisor Caldwell asked how many cities are currently using the software the County is looking at. Mrs. Freeze stated all but Hernando and Walls. Mr. Mitchell stated this project will be done in phases. He stated the payout will be over the 5-year period. Mr. Mitchell also said the typical cost of maintenance is 15% - 20% per year.

Supervisor Lee Caldwell made the motion and Supervisor Michael Lee seconded the motion to approve moving a total of \$872,815, with \$385,200 coming from a portion of the .44 mills excess collections and \$487,615 from capital project fund 315, to Fund 380 in the Countywide Software Project line item as part of the \$1,000,000.00 total transfer for year 1 of 5.

Line 410 - Mr. Mitchell stated this reflects a raise that was given mid-year and now needs to be funded for the entire year.

12. Road Department – Andy Swims – Pages 103 - 110

Page 103 – Mr. Swims stated the Road Department's average spending to operate is \$9,800,000.00. He stated the projected revenues are a little over one million.

Mr. Swims stated the figure on the conceptual building previously discussed with the Board is \$1,200,000.00. Supervisor Medlin asked what Mr. Swims planned to do with the old building. Mr. Swims said they have a lot of need for places to put equipment to keep it out of the weather. Supervisor Caldwell stated it might be a good place for the Parks Department. Supervisor Gardner agreed. Mr. Swims stated the biggest unknown is what is underground. He said if the building is approved, they will start immediately with a geo-tech engineer to do some boring, have someone to look at the conceptual plan, and see how much of the work can be done by the Road Department and Facilities Department. Mr. Swims is convinced they can order a steel structure building and put it together, just as they put up the material storage building. He said they also can do the site work.

Page 106 - Mr. Swims also stated the time has come to get Mr. Young an assistant. He said Mr. Young is swamped and needs help. Mr. Swims reminded the Board they approved funding for this last year. He stated he will be looking for a young engineer or a retired engineer.

Page 107 – Mr. Swims pointed out the four million dollar request for Holly Springs Road. He said the County has been setting aside this money, and there will be no more federal funding. Supervisor Caldwell said the Transportation Committee was going to ask for help from the state and the legislators said they would help push for it. Mr. Swims said the utilities are relocated, and they are ready to go. Supervisor Medlin stated he thought there were federal funds left after the engineering was done. He also suggested trying to do the work in phases and get started. Supervisor Caldwell agreed. Mrs. Lynchard contacted Mr. Huffman; and he said they needed about \$13,000,000.00 to finish, and there was about \$1,000,000.00 left in federal funds.

Mr. Swims stated the Road Department really needs a new limb truck and 2 new operators. Supervisor Caldwell stated she would like to have all the trucks currently owned operational, and educate the drivers and the public about what can be picked up. Mr. Swims stated he has not increased the limb truck fleet in 5 years. Supervisor Medlin asked if the limb truck crew was not picking up limbs, if they had other responsibilities. Mr. Swims stated they do routine maintenance unclogging pipes and cleaning out ditches. Supervisor Medlin asked Mr. Swims to bring figures on the current trucks such as year, mileage, and repairs.

Supervisor Lee Caldwell made a motion to approve the Road Department budget excluding the purchase of a limb truck and hiring a crew for it. There was no second.
